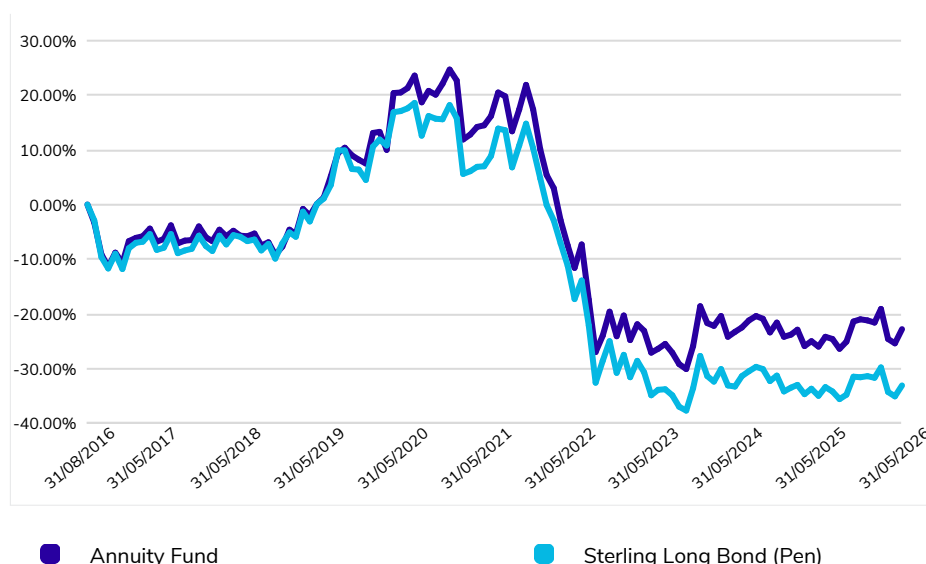

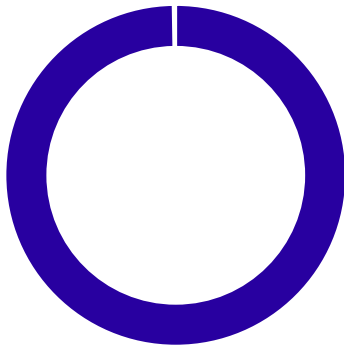

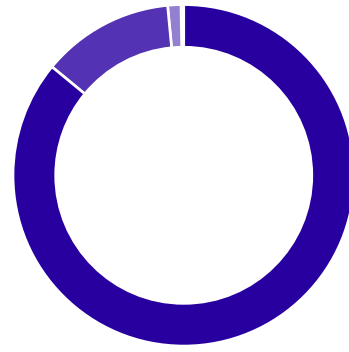
Asset allocation as at 31-05-2026

Asset Breakdown



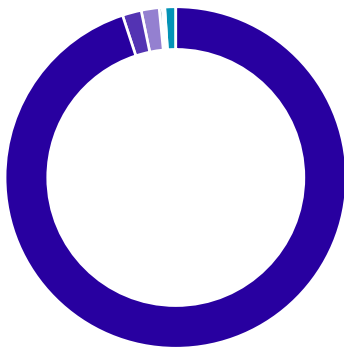
