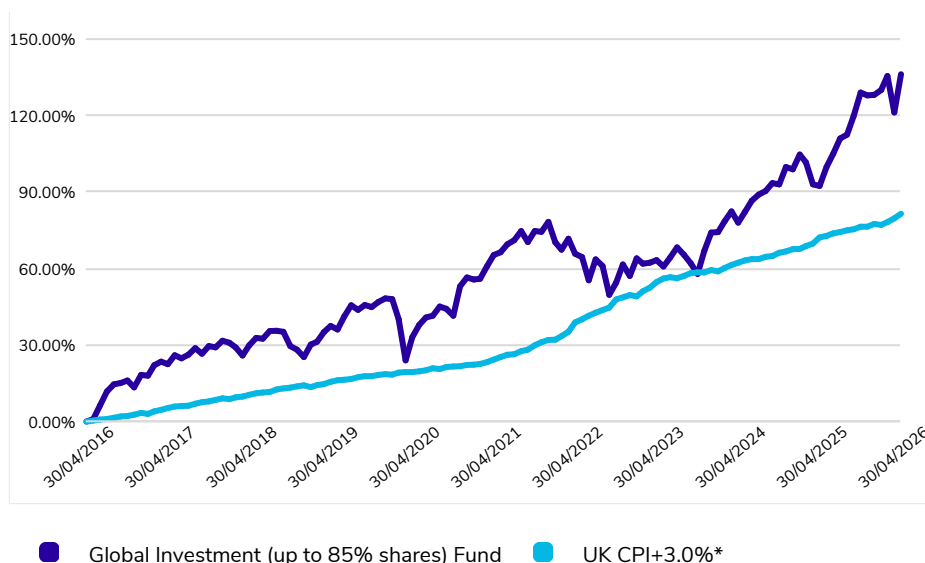

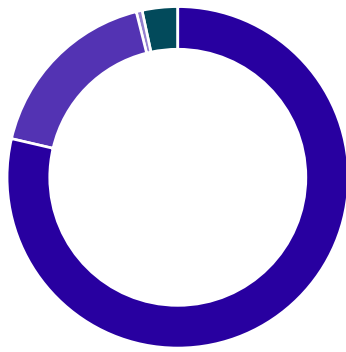

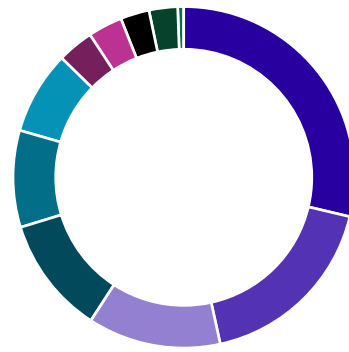
Asset allocation as at 30-04-2026

Asset Breakdown



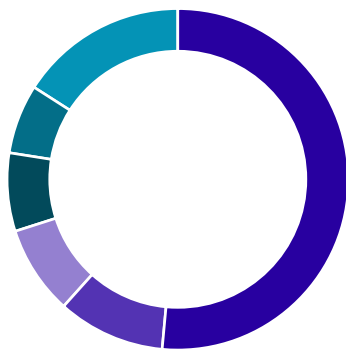
